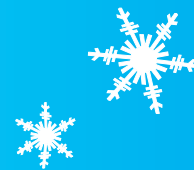

Preventing property crime starts with YOU!

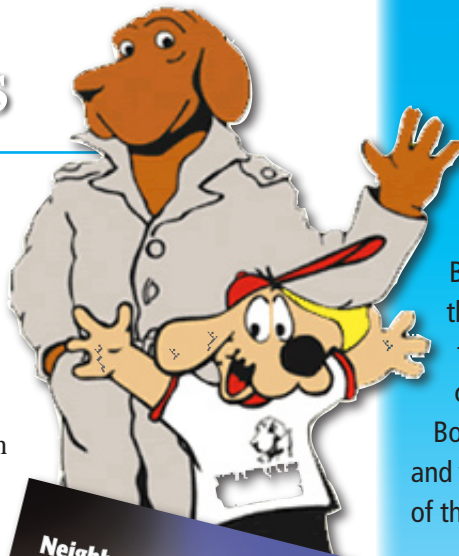
As you have been made aware through email notices from the Association, or through your own unfortunate experience, homeowners in area neighborhoods have experienced a rash of personal property crime over the last few months.

Please be sure to report any incidences to the Poway Sheriff Department, as well as to the Summerfield HOA. We have been in contact with the Sheriff Department to request increased patrol.

Two Board positions open for 2009-12 term

Community pool in compliance with new law

A new federal law requires that all pools and spas used by the public have anti-entrapment drain covers. This drain cover will prevent swimmers from becoming trapped underwater by the suction of the filtration system. In addition, the drains must be installed by certified pool maintenance workers. Due to back-ordered supply of these drains and limited numbers of certified workers, a large amount of public pools are closed until they can come into compliance. We have had our pool drains replaced and are in compliance with federal law. The cost for replacement was \$350 and is a non-budgeted expense.
