Street resurfacing scheduled for Summerfield

After several years of delay, the City of Poway will be repairing/resurfacing the streets in our neighborhood. The project is scheduled to run from March 17 through August 2010. City workers have already been through marking out needed repair areas.

As the next phase begins, temporary NO PARKING signs will be placed near the curb 48 hours in advance of any work beginning. The city asks that you do not park on streets that have been posted with NO PARKING signs and that irrigation systems be turned off when these signs are present so that areas requiring asphalt replacement are dry.
