The total fine for failing to make corrections after the first and second notices is now \$350, with an invoice to be issued. The board reviewed the situation and will make the decision to take formal action at the next meeting.

The architecture committee reviewed a concern about recently approved fences. The
committee believes the fences are in harmony with the neighborhood, consistent with
our stated policies and does not feel any change to policy is required.
