Return the Election Ballot enclosed

Enclosed is a ballot for this year's election for the open Board positions. While it might seem unnecessary to go through the time and expense to hold an election when we can fill the position with the individuals who have volunteered to run, we are mandated to do so in our governing documents (Article III and V of the By-laws) as well as California Civil Code 1363. *Every year, we are mandated by state law to hold an election for new board members, and we must receive at least 51% of eligible ballots for the election to be valid.*

PLEASE HELP US ACHIEVE A VALID ELECTION BY RETURNING YOUR COMPLETED BALLOT!

It is important that the Board be properly elected so that its members can carry out all of the responsibilities dictated in our governing documents and comply with State laws. **As mandated by California law**, your ballot should be returned to the HOA as follows:

- STEP 1: The completed ballot shall be inserted and sealed into the *small blank envelope* provided.
- STEP 2: The envelope containing the ballot identified above, shall be inserted and sealed in the *larger envelope labeled with your name, address and signature line.* Please *sign your full name* as indicated on the label.
- STEP 3: The envelope in Step 2 should be inserted into the envelope that is addressed to "Summerfield Homeowners Association."
- STEP 4: Please *return the envelope by U.S. mail by Monday, May 15th* (requires one First Class postage stamp) or bring the envelope with you to the Annual Meeting on May 22nd.

In compliance with California State law, the Board has appointed election inspectors that will validate, count, and tabulate the ballots at the Annual Meeting. If at that time, a quorum is met (51% of homeowner ballots returned), the election inspectors will disclose the results. If there are not enough returned ballots available at the Annual Meeting; subsequent to the meeting, the election inspectors will work to gather a quorum of ballots and report to the Board the election results when a quorum has been obtained.

Future SHOA Communications

If you haven't done so already, send us your email to continue to receive HOA communications. We are always looking for ways to save HOA funds. One way is that we no longer use regular mail for most communications from the HOA (ballots and invoices are still sent via regular mail). If you wish to receive periodic news and updates from the HOA, please send us your email address. Your email address will only be used to communicate Summerfield HOA-related information. We will not publish your email address or distribute it to anyone else, including other homeowners in our neighborhood. To be added to the email distribution list, send an email with your name, address, and phone number to: summerfieldpoway@gmail.com. If you own a home and have a renter, your tenant's email is welcome as well and we can keep them up to date on neighborhood happenings.
