3. Security Deposit. Owner hereby agrees to pay the Association \$ prio	
use of the common area. Such deposit may be used by Association to pay any expenses of clean	
and repairs or replacements required after use of the common area by Owner. Refund of any unu	
deposit or requirement of payment of additional deposits shall be at the discretion of the Association	JII.
4. <u>Liability Insurance</u> . Owner shall obtain a general comprehensive liability policy	of

insurance in the amount of \$300,000 to cover, among other things, Owner's guests and agents during the use of the common area for the private party, and shall name Association as an additional insured

on such policy. The coverage under Owner's policy must expressly state it is primary to any insurance carried separately by the Association. Owner's insurance must also clearly state it has coverage for Owner's intended use including, but not limited to, installation, use and removal of a on Association's common area.
5. <u>Covenants</u> .
(A) Owner and Owner's invitees, guests, and any persons admitted to the common area by Owner, shall comply with all laws of the United States, the State of California, all ordinances of San Diego County, and all rules and requirements of the local police and fire departments.
(B) Owner or Owner's invitees, guests, and any persons admitted to the common area by Owner, shall not injure nor damage in any manner the common area, and shall not cause or permit anything to be done whereby such common area shall be in any manner damaged, marred, or defaced.
(C) If during the term of this Agreement any portion of the common area shall be damaged by the act, default, or negligence of Owner or any of Owner's invitees, guests, or any persons admitted to the common area by Owner, Owner shall pay to Association, upon demand, any and all costs and fees to make repairs or replacements.
(D) Owner shall be responsible for any attorneys' fees and costs incurred by Association in enforcing any provisions of this Agreement.
(E) Association reserves the right to eject any person or persons behaving in a disorderly manner or contrary to the rules and regulations of Association, and to prevent any damage to or destruction of the common area during the period of Owner's use.
(F) Owner shall use the common area in a proper and safe manner, and neither the Association nor any of its employees, agents, officers, or directors shall be responsible for instructing or otherwise supervising Owner's use of the common area.
(G) Owner shall not use the common area if any health condition of Owner makes such use dangerous or hazardous to Owner or any other person using the common area.
